Notice to the respondents returnable by six weeks.

Private notice is also permitted.

There shall be an order of interim stay on condition that the petitioner deposits a sum of Rs.1,00,000/- (Rupees one lakh only) to the credit of this writ petition, within a period of six weeks from the date of receipt of a copy of this order, failing which this order would stand automatically cancelled without further reference to this Court.
